Deputy Martinez said there has been an increase in ATVs and UTVs around the area.

Municipal Code Officers Report.

MCO Sullivan reviewed the report.

Report consists of a lot of grass, weeds and hard surface violations. President Troutman said that the Village needs to take the violations seriously and proceed if violations are not completed.

President Troutman and MCO Sullivan are going to reach out to the lien holders of the former Alcoa Property and let them know about the condition of the property.

Trustee Gilroy asked about the trailer park. MCO Sullivan said that information was requested under the Freedom of Information Act, and the State has written them up, dating back to 2018.

MCO Sullivan reported on the grant he is working on with Discover Peoria. This coming Monday will be four (4) weeks after submitting the grant, and The Village should hear something by the end of June or early July.

Trustee Delbridge made a motion to Approve an Ordinance Approving and Adopting FY 2023 Residential Redevelopment Program for the Princeville Tax Increment Financing District, totaling \$50,000 (\$30,000 will be allocated for residential projects and \$20,000 will be allocated for commercial projects). Trustee Gilroy seconded the motion.

Presidents Troutman said that receipts would be required as proof of purchase and work completed. The maximum reimbursement for a resident would not exceed \$2,500. The application will have the rules, regulations, and guidelines.

Like the Princeville commercial program, the residential program would be limited to property owners located in TIF District 1. Property owners can check their tax bills or call Village Hall to determine if they are eligible.
