President Troutman discussed High Voltage Tap inquiring about selling sandwiches on Saturday during Heritage Days in the alley area behind bank. They are not able to use parking spaces due to an event taking place along Main Street. President Troutman wanted to ask the Trustees their thoughts. A few things – that is the only exit from the bank, the Feed Store will be closed due to limited parking, and there will be an event taking place in the street. Trustee Delbridge commented that the Village already had the conversation with them about selling sandwiches during Heritage Days. President Troutman will get in contact with them again. If something can be worked out, the Village is happy to work with them.

Treasurer Delbridge said there are two (2) CDs at Princeville Bank that will mature next week. She spoke with our contact at Muni-Link. Tricia Schupbach and Tiffany Day addressed the board. This is the 11th year for the Princeville to Peoria St. Jude Run. It will take place August 5th. In 2022, they raised \$101,000. They are appreciative of any donation the Village would be willing to make.

The length of this agreement would change if the State of Illinois mandates a resource officer be present in the schools.

Report from the Superintendent of Public Works

- Cancelled seal coating because the contractor could not guarantee it would be done by September.
 - Doing spray patching - \$20,000 was approved as part of the budget for that project.
- Sidewalks and curb/gutter are all done. All sidewalks should be open. Driveways will be closed until the end of the week.
- Carnival/Lions Club/PCA have requested garbage cans and picnic tables.
- Well #2 had a clean sample. After another clean sample, the well should be back in operation tomorrow.
- Joey will put No Parking signs along Cottage Grove.

President Troutman commented that there was a directional sign off Craig Street for directions to the Aquatic Center. Superintendent Gardner will make sure those signs come down.

Any Other Business to be Brought Before the Board

Treasurer Delbridge said that Joe Sarnes asked about building permit fees when something was damaged by fire. Do we still charge a fee for the building permit? Yes, the Village has to charge the fee for the purpose of Zoning and Peoria County fees.
