MCO Sullivan is aware of the stop sign at Santa Fe and Spring Street, and what a dangerous intersection that is. There is a vehicle parked along that right-of-way that makes it difficult to see and stop where vehicles are supposed to.

He is currently working with the property across from the school. The owner has been dumping items there. MCO Sullivan and the attorney agree that a permit should not be issued to anyone who has a pending violation on the officer's report list (Joey is aware of this).

A citizen on Spring Street continually has high grass, there are complaints about it each year, and it draws animals. President Troutman and Trustee Schoenbeck agree that the property owner needs to mow first, and follow the residential codes. MCO Sullivan will meet with the property owner again.

Trustee Pope said there is a trailer along Walnut Avenue that hasn't moved in some time and suggested MCO Sullivan take a look.
