### **Municipal Code Officer's Report**

He reviewed the new violations list. He is working on the Spring Street violation and assisting with animals that are not allowed in town.

With regard to the property at 336 East Evans Street, an invoice has been sent to the owner. If the Village does not get a response, file a lein against the property. The invoice was for a few thousand dollars worth of work.

The property at 335 South Tremont is currently vacant. MCO Sullivan has put an abate sticker on this property, reached out to the attorney and he is working to follow the procedure per the attorney.

MSO Sullivan will have an update about the Alcoa Property at another meeting.

President Troutman said we need to follow ordinances, and the attorney is working on redrafting the language. There should be updated ordinances for the Village in the coming weeks. MCO Sullivan said the current way is the resident goes to court and gets fined \$50. With the new way (ordinance) trying to prevent the \$50.00 fine and daily fines could be up to \$750.00.

Trustee Peterson said there were campers that have not moved at 120 East Craig and 603 North Sant Fe. President Troutman said the camper on Craig Street might have someone staying there, as they are doing some remodeling at the residence.

### Ashley Hildebrandt and Elle Benway from Discover Peoria to Address the Board

Ashley Hildebrandt and Elle Benway represented Discover Peoria. Discover Peoria covers seven (7) counties in the area, focusing on tourism and economy within the community.

The Village of Princeville has signed a five (5)-year contract with Discover Peoria. We are almost two (2) years in and wanted to check in to see how everything was going.

They reviewed performance material spanning the time of July 2022- June 2023, also broken down quarterly. Princeville started with 15 listings and now has 23 listings.

Ashley meets quarterly with President Troutman and Julie to review what needs to be highlighted and marketed. Next quarter, there will be a lot of promotion of The Pumpkin Place, Garden Spot, etc.

Discover Peoria is working on a video of Princeville. Once it is finished, it will live on the Princeville landing page.

No payment until September 2024. September 2028 would be the fifth payment. After that payment, the Village can trade-in or purchase. With the payment difference, this Caterpillar quote was still the cheaper quote.
