#### **Roll Call**

President Pro-Tem Delbridge informed the Village Board that President Jeff Troutman sought to attend the meeting remotely due to employment obligations.

Trustee Peterson made a motion to accept President Troutman's meeting attendance via Zoom due to employment obligations. Trustee Gilroy seconded the motion.

#### **Public Comment Period**

Michael Harmon fully supports have a 4-way stop at the intersection of West Main Street and North Cottage Grove roads. He is curious as to why the potential 50 ft parking ban prior to the stop sign. It seems excessive, and why that is not the case anywhere else within the Village. He anticipates that will be addressed when that agenda items comes up.

There is one CD at Morton Community Bank, ending in 2389, for \$100,000, that Treasurer Delbridge asked the board for permission to move the CD if Morton Community Bank would not match the rates of another bank, and the board indicated for her to do so, and move it, if they would not match the rate.

The State Bank of Toulon has a 7-month CD, 4.74%, that Treasurer Delbridge would like to pursue, if Morton Community Bank will not match.

# Consider and Vote to Approve an Ordinance Authorizing Placement of Stop Signs and Establishing No Parking Zones at the Intersection of West Main Street and North Cottage Grove Avenue.

Superintendent Gardner stated that the state law is a minimum of 30ft, from the stop sign. With two of these being new stop signs, he'd like to put out 'No Parking here to Corner' signs, paint the curbs yellow, and put flags on the stop signs.

Trustee Potter was ok with 30 ft of no parking, going all directions. He wanted to be sure everyone can see what/who is coming.

Trustee Delbridge said the Water and Sewer committee met tonight to discuss city water rates. The attorney is going to correct/update the fee schedule as written in the code book. (The Village wants to clarify, that the \$5.69 per 1,000 gal begins with 0 gallons.) The committee will not be changing any rates, but rather the language, and will be voted on during item 12 tonight.

**TIF Committee Meeting**, September 17, 630pm: Discussion about Proposed Intergovernmental Agreement Between Village of Princeville and Akron-Princeville Fire Protection District.

Trustee Gilroy discussed an intergovernmental agreement between the Village of Princeville and Akron-Princeville Fire District. The Board is voting on this in item 13 tonight.

# Consider and Vote to Approve an Ordinance Adjusting User Rates for Village's Water and Sewer Systems.

President Troutman reiterated this ordinance will adjust the language, and not the rates regarding the Village water systems.

# Consider and Vote to Approve an Ordinance Approving and Authorizing the Execution of an Intergovernmental Agreement by and Between the Village of Princeville and Akron-Princeville Fire Protection District.

President Troutman stated that Trustees of the Akron-Princeville Fire Protection District can not vote on this, but the fireman can vote.

Trustee Gilroy made a motion to Consider and Vote to Approve an Ordinance an Ordinance Approving and Authorizing the Execution of an Intergovernmental Agreement by and Between the Village of Princeville and Akron-Princeville Fire Protection District, for the total amount of \$102,699.07, 25% of the requested amount will be dispersed each years, for four (4) years, \$25,674.677 each year. ### **Report from the Superintendent of Public Works**

- A drone was used to check on the water-tower by the District office. It looks to be a discoloration from algae.
- The new storage shed has the columns are in the ground, and the rest should be erected Monday.
- The 'Autistic Child' signs were put up in the 500 block of S. Santa Fe.
- The new Stop signs will be installed. The Village has everything they need.
- Sealcoating is completed. We need some rain before the streets will be swept.
- Christmas trees went up \$7.00 a tree.
- He is working on the plat from Wallace Engineering for the pool group.
- Water system had its EAP inspection. One item that was mentioned was that the Village water rates have not been adjusted since 1998. (The EPA set the rates to repay the loan for the EPA.) (
- The Village has received a few Cross-connection surveys. (These are to see if there is contaminated water anywhere.)
- One of the tanks ran out of water for the reverse osmosis. The controls went bad but it did not require a boil order.

# Any Other Business to be Brought Before the Board

Trustee Pope set a Health Committee meeting, to discuss the 2025 health insurance rates with the Wyman Group. The meeting was set for October 22<sup>nd</sup> at 6:30 PM.

Trustee Peterson commented that there were some guests present. Representatives from West Jersey Express are moving forward with their trucking company having a third location at the old Alcoa property. They have a lot of work to do on the building, but will work to beautify the location. They are looking forward to being in Princeville, and are unsure of the number of employees they will have working at this location. President Troutman welcomed and thanked them, and reminded them of the TIF, and to bring any proposals forward.
